## Club Release Form

The undersigned (on my own behalf and on behalf of my heirs, personal representatives, successors and assigns), in consideration of the opportunity to participate in Water Volleyball or "Activity" (hereinafter, EVENT(S)) sponsored and/or conducted by the Water Volleyball Club and its respective steering committee officers, directors, employees and agents including the Lincoln Hills Community Association (hereinafter, the "RELEASED PARTIES"), releases and holds harmless the RELEASED PARTIES from any and all claims, demands, rights and causes of action of any kind whatsoever which I now have or later may have against the RELEASED PARTIES in any way resulting from, arising out of, or in connection with my participation.

This Release extends to any and all claims resulting from or arising out of their performance of club duties whether or not such claims result from negligence (except willful neglect) with respect to the EVENT(S), the conditions, qualifications, instructions, rules or procedures under which the EVENT(S) are conducted, or any other cause.

**I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE RELEASED PARTIES** for any injury to myself or my property arising from, or in connection with, their duties in sponsoring, planning, or conducting the events.

I, the undersigned, recognize that participation in water volleyball involves inherent risks, including but not limited to slips, falls, physical contact with other players, and potential injury from water-related activities. I acknowledge that I am voluntarily participating in these activities at my own risk. I understand that

I expressly agree to assume the entire risk of any accidents or personal injury, including death, to myself or my property because of participation, including any negligence (except willful neglect) on the part of any or all the RELEASED PARTIES.

### **WAIVER OF RIGHTS UNDER STATE STATUTES**

I waive all benefits from any state statute which would negate or limit this release, including California Civil Code Section 1542:

"A general release does not extend to the claims which the creditor does not know or suspect to exist in his favor at the time of executing this release, which if known to him must have materially affected his settlement with the debtor."

By signing, I certify I have read this Release, fully understand it, and am not relying on any statements or representations made by the RELEASED PARTIES.
