MEETING CALLED TO ORDER by Diane Ferrari acting Chairperson during Joe Keller's absents. The meeting was called to order at 3:01

TREASURER/MEMBER REPORT- Chip Hill

Chip sent the financial reports since he was unable to attend.

• There was 1 new club member since the last Steering Committee meeting.

- As of this meeting 121 paid members 6 members are still New and one member is Inactive planning to come back this summer.
- Current bank balance after all checks clear is \$6,681.72
- With the new membership of the Steering committee, we needed to change the signatories on the UMPQUA business checking account removing Cindi Underwood and adding Joe Keller. UMPQUA is still waiting on Chips signature all other documents are complete.

SOCIAL COORDINATOR: Terri Vallis

Tentative dates set for the following events:

Is currently working trying to get a band approval for Cinco De Mayo and Fall Feast at which point Terri will submit for steering committee approval. Terri is also looking at putting together a Pizza party however Old Town Pizza wanted a credit card to make ensure a minimum of \$800.00 was spent. Terri will look at the new Pizza place on Sterling parkway.

- Cinco De Mayo is on May 5th which is a Friday tentative schedule
- Fall Fest is being planned for October 13th or the 20th for a potential date
- Would like to plan something indoor for the holiday party. Potential of getting Kilaga as a venue.
- Outdoor volleyball will be scheduled, dates to be determine. Would like to schedule 3 times if possible.

NEW MEMBER/MENTOR COORDINATOR: Jerry Grisler-Jerry is proposing an amendment to operating policy and procedures. The proposal is to require a 30-day waiting period in Rec/CRB before advancing to competitive ball. A recommendation was made to change wording from REC/CRB to just Rec.

A motion was made to amend the current policy to read "In order for a new member to properly learn the game (i.e. Serve, Pass, Set, Block) and at the discretion of the Recreational Play Coordinator and Competitive Play Coordinator, it is recommended a player remain at Rec for a Minimum of 30 Days before advancing. Motion was made by Carol Critch and seconded by Steve Bourn passed a vote of 6 in favor of and 1 opposed.

RECREATIONAL COORDINATOR: Andee Lund

COMPETITIVE PLAY COORDINATOR: Kim Bovee.

Discussion on serving position. Kim has received 18 complaints regarding the number of competitive players wanting to serve in the middle of the court. Policy already reads competitive players need to serve from the servicing box. A potential revision should be done if further clarification is needed. Potentially a survey will be completed before any changes.

Roster members who do not participate in team play. There are 6 level four players that have not played in months and multiple level 4R players that do not play. Waiting on rankings before any changes.

Level 4R players are not able to play as a sub since they are not ranked and the policy makes no provision for level 4 to allow substitution. Policy will need to be changed and policy rewritten to be submitted next month.

Since the March ranking are coming out soon a recommendation was made for the top 5 players for level 4 and 5 be added to the online sign-up sheet in order for the level 6 and level 5 players to know whom they can call for a sub or a replacement. To be presented and voted on during the next meeting.

Policy states that a player must have played to vote during the ranking period. In the past members were able to vote regardless if they were present or not. Policy will need to be re-worded for clarification.

It was noted the Official Policies and Procedures Guide on pages 11-12 does allow Competitive players to stand anywhere within the right half of the court facing the net as long as they remain within an arm's length of the back boundary.
