Jul 1, 3C Play

- Harriet apologized for scheduling 9 players for 3C play on Jul 1. She didn't realize it would be an issue. It was intended to be a way for the players to see the difference with having 9 players, before they signed the petition to request the change to 9 players.
- Harriet gave Sidne the Petitions to increase 3C to 9 players.
- 8 of 14 Level 3C players signed the petition.

Discussion / Q&A

- Eric asked why they want 9 players. Harriet stated this is explained in the petition. She said the ball goes in-between and behind when they play with 8. They had better play with 9 before changing to 8. They want to work on their skills to pass-set-hit.
- Cindi thanked Harriet for her apology re: playing 9 members before the petition was vetted by the RPSC and approved by the SC. She stated the rules were broken.
- Eric agreed with Cindi, ie the rules were broken. Also asked why Kalli played on Jul 1, ie moving from L5 to L3C, instead of L3, when the RPSC originally didn't want L4 moving down to L3C without a qualification process.
- Sandy stated Kalli called Harriet to ask to get on the roster. Part of this is due to Harriet running the Ladies Night, and the assumption is Kalli wanted to play and Harriet made it happen.
- Kim stated she thought this was an honest mistake.
- Cindi stated there was a comment that they were "going rogue". And this is why all 4
 members of the RPSC resigned ie not following the process to take petition to RPSC
 for discussion and their subsequent recommendation to the SC for final approval.
- Cyndi stated during her time as chairperson, it seemed nobody was happy and there was a lot of frustration. She was spending over 20 hours per week to manage the program. When this incident occurred, the perception was there was no confidence in Cyndi's leadership. It wasn't just this one event that caused her resignation.

- Sandy agreed to temporarily manage the L3C Captain's list.

The Steering Committee is supportive of the Level 3 Competitive (L3C) program, and all want it to succeed. There is some concern that the coordinator position has required a great deal of time. Balancing responsibilities among committee members was advised and will be encouraged with the new committee.
